Withdraw an Application

Under the Private Security Personnel and Private Investigators Act 2010

What is this form used for?
Use this form to withdraw an application made to the Licensing Authority.

 - Print clearly in CAPITALS.
 - Use a black or blue pen to complete this form.
 - Answer every question on the form unless the instructions tell you otherwise.
- 3 Payment information

There is no fee for withdrawing an application.

Withdrawing your application will not result in a refund of your application fee. If you resubmit your application at a later date you will need to pay a new fee.

Confirmation of withdrawal
We may contact to you confirm the withdrawal of your application.

5 Important information

You may not withdraw an application on behalf of someone else (eg: an employee cannot withdraw an application on behalf of a company, and a company officer cannot withdraw an application on behalf of an employee). In the case of a company licencee, only a company officer may withdraw an application.

6 How long will it take to process your withdrawal

In normal circumstances it will take 3 working days to process your withdrawal.
